## Important Information Regarding Your Fund's Distribution

### November 30, 2015:

The following table provides an estimate of the source of the November 30, 2015 distribution made by Ares Dynamic Credit Allocation Fund, Inc. (the "Fund"), based on the Fund's fiscal year-to-date activity. This information is being provided pursuant to Section 19(a) of the Investment Company Act of 1940, as amended. This estimate is based on U.S. generally accepted accounting principles ("U.S. GAAP"), and is not intended to be used, nor should it be used, by stockholders in preparing any tax return, determining the amount of any tax due, or for any other tax reporting purposes.

<sup>(2)</sup> This amount may represent a return of the stockholders' principal, unrealized capital gains that may be recognized prior to the Fund's fiscal year-end, or some combination thereof. Should the Fund's net income or capital gains position change, the fiscal year-to-date amounts will be updated to reflect those changes.

In 2016, the Fund will send to stockholders such tax information reporting forms (*e.g.*, Internal Revenue Service Form 1099-DIV) as are required by applicable law. Those tax information reporting forms will contain information that the tax authorities require the Fund to provide to stockholders, which includes information about how the Fund is reporting the character of distributions paid by the Fund to the applicable tax authorities along with other information required to be reported under applicable law.
